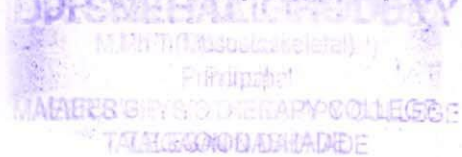

The Academic Council has unanimously resolved vide its resolution No. 59/2021 to grant Continuation / Extension of affiliation to the B.P.Th. course of your college for the academic year 2021-2022 subject to following conditions:

- The intake capacity shall be **B.P.Th. - 60**
- It is mandatory to obtain the State Government permission (as applicable).
